

The Principal, Dr. B. C. Shanthappa welcomed all the members present in the meeting. The Committee is discussing the issues as below.












The Principal is also directed the GRC Coordinators to demonstrate the use of online grievance redressal portal, for all the Cell members.


Finally, the meeting is concluded by the principal with vote of thanks.
